The FAIM label is your global assurance for a smooth, safe and comprehensive relocation process. Customs authorities apply very strict control to all incoming shipments in relation to their precise weights. It is essential that the declared weight on the bill of lading (OBL) coincides precisely.

- Non-commercial amount of gifts and other items for personal use. 




