On May 13, 2025, the New York State Energy Research and Development Authority (“NYSERDA”) released a draft Index Storage Credit Request for Proposals (ISCRFP25-1) for bulk energy storage projects (the “Draft RFP”). ISCRFP25-1 is the first of three solicitations planned by NYSERDA in service of.


